Dear Friends,

You helped surround more than 15,000 pediatric patient families with love and practical support from Ronald McDonald House of the Intermountain Area (RMHC) last year. This is nearly 40% more families than we were able to serve in the prior year! Together we give families what they need to be near and care for their seriously ill or injured children.

Looking over what we accomplished together, I feel such deep gratitude. Our family-centered care includes free lodging, food, and transportation to and from hospitals. Our volunteers shared over 37,000 hours of service valued at more than \$1.2 million. That's a 25% increase from the prior year. Together we provided over 76,000 free meals at our Ronald McDonald House® and hospital-based Ronald McDonald Family Room® programs.

It was a remarkable year! We saved patient families \$9.2m in 2024 in lodging and meal costs alone. And in addition to meeting basic needs of lodging, food, and transportation, we offered joyful distractions, compassionate family centered care, skilled grief and mental health support, and meaningful connections to community resources.

We are deeply committed to doing more of what we do, better than we've ever done it. Our growth continues. In March of 2024, we were thrilled to open a new Ronald McDonald Family Room® program in the newly constructed Intermountain Primary Children's Hospital on the Miller Family Campus in Lehi. This Family Room offers four private overnight family guest rooms, a fully stocked kitchen with meals lovingly prepared by volunteers and staff, dining area, living room, quiet meeting spaces, showers, laundry facilities, guest computers, natural light, and beautiful mountain views. More than 1,800 families were served in the program from March through December!

Hospital Programs

Ronald McDonald Family Rooms

Our Ronald McDonald Family Rooms offer families of hospitalized children places to rest, sleep overnight, eat, shower, do laundry, and more—all within the hospital, just steps away from their child's bedside. We were thrilled to add a new Ronald McDonald Family Room in Utah County in 2024. It serves the beautiful new Intermountain Primary Children's Hospital Miller Family Campus in Lehi.

At Intermountain Primary Children's Hospital in Salt Lake City, we host three Ronald McDonald Family Rooms. 2nd Level Family Room at PCH serves parents with a child being treated in the Pediatric ICU, Neuro Trauma Unit, and Cardiac ICU. Our Family Room on Level 3 is available for families, children, and guests to visit together. Another Family Room on Level 4 serves the Pediatric Hematology, Oncology, Cancer, and Neonatal Intensive Care Units.

We also have a Family Room located at the University of Utah Hospital (UofU), serving parents with children in the Newborn ICU.

The Cart serves patients and families of the Newborn ICU, Pediatric Unit, and Labor and Delivery Unit. Its mobility allows it to bring a feeling of welcome and support directly to patient rooms. Our dedicated staff and volunteers make sure everyone they interact with feels the love and comfort of our mission, made possible by our community!

Family Support Specialist



Maria Gamvroulas serves as RMHC's Family Support Specialist Manager. She helps provide a safe and welcoming space for families to seek deeper support during their stay at the Ronald McDonald House.

In 2020 RMHC partnered with the Cambia Health Foundation to begin a pilot program for a new Family Support Specialist Manager position to help address the complex challenges rural families with a seriously ill or injured child face in accessing medical care, with the emerging trends toward outpatient care. In 2021 the Cambia Health Foundation endowed the Family Support Specialist Manager position with a \$1.25 million grant.

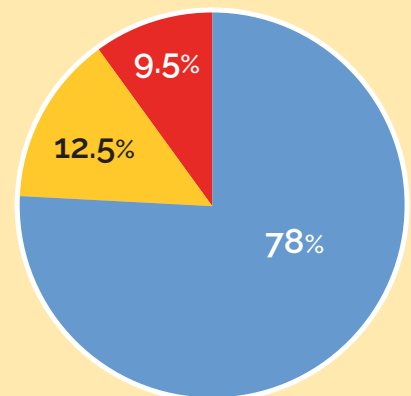
